## Rules and Regulations

BY THE

### LOCAL GOVERNMENT BOARD FOR IRELAND

#### FOR THE

### **Regulation of Burial Grounds**

WHEREAS, by "The Public Health (Ireland) Act, 1878," it is amongst other things enacted, that it shall be lawful for the Local Government Board for Ireland, from time to time, to make such rules and regulations in relation to the Burial Grounds and places of reception of bodies previous to interment which may be provided under the said Act, as may seem proper for the protection of the public health and the main-tenance of public decency, and for the proper registry of interments; and to provide for the imposition and recovery of penalties, not exceeding Ten Pounds for each offence, for the breach or non-observance of such regulations.

Now, We, the Local Government Board for Ireland, in pursuance of the powers vested in us by the said Act, or otherwise howsoever, do hereby make the following Rules and Regulations, which shall apply to all Burial Grounds provided, or which may be provided, under the aid Act, that is to say-

I. Every Burial Ground shall be kept sufficiently fenced; and, if necessary, shall be underdrained to such a depth as will prevent water remaining in any grave or vault.

II. The area to be used for graves shall be divided into grave-spaces, to be designated by convenient marks, so that the position of each grave-space may be readily ascertained. A corresponding map or maps of the Burial Ground shall be constantly kept in some convenient place, at or near the Burial Ground, and shall be open to the inspection of all persons. On such map or maps every grave-space shall be shown with its distinctive mark inscribed thereon.

HI. The grave-spaces for the burial of persons above twelve years of age shall be at least nine feet long by four feet wide; and those for the burial of children under twelve years of age shall be at least six feet long we three feet wide. w three fect wide

IV. Each grave, when opened for the first interment therein, shall be sunk to the perpendicular depth of eight feet at the least; and every person interring a body in a grave not sunk to such depth shall be liable to a penalty of Two Pounds sterling.

V. No interment shall be permitted in any Burial Ground, nor shall any dead body be admitted into any place of reception of bodies previous to interment, unless the body be enclosed in a coffin of wood or other sufficiently strong material. Any person presenting a body for inter-ment in violation of this Rule shall be liable to a penalty of Two Pounds

VI. One body only shall be buried in a grave at one time, unless the dies be those of members of the same family; and every person terring any body in violation of this Rule shall be liable to a penalty Two Pounds sterling.

VII. No unwalled grave shall be re-opened within fourteen years fter the burial of a person above twelve years of age, or within eight ears after the burial of a child under twelve years of age, unless to bury nother member of the same family, in which case a layer of earth not a than one foot in depth shall be left undisturbed above the previously wide cofin ; but if on re-opening any grave the soil be found to be densite, such soil shall not be disturbed. In no case shall human mains be removed from the grave. Every person acting in violation i this Rule shall be liable to a penalty of Two Pounds sterling.

VIII. No coffin shall be buried in any unwalled grave unless the lid upper surface thereof shall be sunk to a depth of at least four feet low the ordinary level of the ground, and every person acting in relation of this Rule shall be liable to a penalty of Two Pounds sterling.

IX. Any person unlawfully preventing or attempting to prevent e interment of any person in a Burial Ground, or unlawfully preventing disturbing the celebration of funeral rites over any person, shall be the to a penalty of Five Pounds succong.

X. No grave, in which any body has been interred, shall save for the purpose of interment or the erection of a tombston stone, without the written order of a Coroner or Peace Commi the County, to be previously produced to and left with the Any person violating this Rule shall be liable to a penalty of Te sterling.

XI. No body, nor the remains of any body, shall be remo one place of burial to another, or exhumed (except under the c set forth in Rule X.) without a Licence from the Local Go Board, and with such precautions as such Board may prescrit condition of such Licence; and any person who shall remove in removing any such body or remains contrary to this Rule shall neglect to observe the precautions prescribed as the con the Licence for removal, shall be liable to a penalty of Ten sterling. sterling.

XII. A proper Registry Book (hereinafter referred to as the Book), made of parchment, or vellum, with strong binding and printed pagings, and ruled in columns with proper printed h shall be constantly kept in some convenient place at or near th Ground, and shall be open for inspection at all reasonable tim no person, except the person having the care and managemen Burial Ground, and in these Rules called the Registrar, shall mitted to write in the Registry Book save as hereinafter mentio

A printed copy of these Rules shall be kept constantly affixe Registry Book.

Any Registrar refusing to give inspection of the Registry E required by this Rule, shall be liable to a penalty of Five Pounds s and any person whatever unlawfully writing in, defacing, alte mutilating the Registry Book, shall be liable to a penalty of Five sterling.

XIII. Before the interment of any person in a Burial Ground, or admission into such place of reception as aforesaid, the Registra after due inquiry as to the facts from some relative of the de or from the person having the direction and management of the ment, cause an entry to be made in the Registry Book, in pla-legible characters, under its proper headings, and in numerical of the Christian and Surname, time of death, sex, age, religion suasion, and occupation or rank in life of the deceased, together his or her last place of residence, and condition, as whether "man or "single," "widower" or "widow," or "the child of of \_\_\_\_\_\_\_ etc. After the interment entry shall be made under its proper heading of the distinctive of the interment shall be affixed in the last column but one, in of the accuracy of the foregoing statements; and such signature be attested by the signature of the Registrar, in the last column, such person wilfully refusing to give to the Registrar information the matters aforesaid, or to affix his signature as aforesaid, sh hable to a penalty of Five Pounds sterling.

And We, the Local Government Board for Ireland, in further pursu of the powers vested in us under and by virtue of the said Act, do he enjoin and require all Burial Boards, and all Registrars, Clerks other persons having the care of such Burial Grounds and places for reception of dead bodies, strictly to conform and to obey these Rules and Regulations, of which all persons concerned are direct take notice, and which are to take effect from the day of the date h



WHEREAS, by "The Public Health (Ireland) Act, 1878," it is amongst other things enacted, that it shall be lawful for the Local Government Board for Ireland, from time to time, to make such rules and regulations, in relation to the Burial Grounds and places of reception of bodies previous to interment which may be provided under the said Act, as may seem proper for the protection of the public health and the main-tenance of public decency, and for the proper registry of interments; and to provide for the imposition and recovery of penalties, not exceeding Ten Pounds for each offence, for the breach or non-observance of such regulations. regulations.

Now, We, the Local Government Board for Ireland, in pursuance of the powers vested in us by the said Act, or otherwise howsoever, do hereby make the following Rules and Regulations, which shall apply to all Burial Grounds provided, or which may be provided, under the aid Act, that is to say-

I. Every Burial Ground shall be kept sufficiently fenced; and, if necessary, shall be underdrained to such a depth as will prevent water remaining in any grave or vault.

II. The area to be used for graves shall be divided into grave-spaces, to be designated by convenient marks, so that the position of each grave-space may be readily ascertained. A corresponding map or maps of the Burial Ground shall be constantly kept in some convenient place, at or near the Burial Ground, and shall be open to the inspection of all persons. On such map or maps every grave-space shall be shown with its distinctive mark inscribed thereon.

HIT. The grave-spaces for the burial of persons above twelve years of age shall be at least nine feet long by four feet wide; and those for the burial of children under twelve years of age shall be at least six feet long by three feet wide

IV. Each grave, when opened for the first interment therein, shall be sunk to the perpendicular depth of eight feet at the least; and every person interring a body in a grave not sunk to such depth shall be liable to a penalty of Two Pounds sterling.

V. No interment shall be permitted in any Burial Ground, nor shall any dead body be admitted into any place of reception of bodies previous to interment, unless the body be enclosed in a coffin of wood or other sufficiently strong material. Any person presenting a body for inter-ment in violation of this Rule shall be liable to a penalty of Two Pounds trading

VI. One body only shall be buried in a grave at one time, unless the odies be those of members of the same family; and every person iterring any body in violation of this Rule shall be liable to a penalty Two Pounds sterling.

VII. No unwalled grave shall be re-opened within fourteen years fter the burial of a person above twelve years of age, or within eight ears after the burial of a child under twelve years of age, unless to bury nother member of the same family, in which case a layer of earth not as than one foot in depth shall be left undisturbed above the previously mild coffin; but if on re-opening any grave the soil be found to be tensive, such soil shall not be disturbed. In no case shall human mains be removed from the grave. Every person acting in violation this Rule shall be liable to a penalty of Two Pounds sterling.

VIII. No coffin shall be buried in any unwalled grave unless the lid upper surface thereof shall be sunk to a depth of at least four feet low the ordinary level of the ground, and every person acting in clation of this Rule shall be liable to a penalty of Two Pounds sterling.


